***UW-Platteville offers a tuition waiver to full-time international students in the amount of \$5,000 per year (\$2,500 per semester). International students may receive this tuition waiver for up to 8 academic semesters providing that they remain full-time students in good academic standing.

You are required to certify that you have \$22,425 available for 2 semesters of study at the University of Wisconsin - Platteville. You may use the international student waiver of \$5,000, in your first year, to reduce that amount to \$17,425. You must also indicate how you will meet your expenses for subsequent years of study (note projected 7% annual increase) if you expect your program to require more than one year's stay. The University of Wisconsin-Platteville encourages students to pay tuition, fees, housing and food costs in full at the beginning of each semester to avoid finance charges and/or late fees.

The purpose of this financial verification requirement is to prevent you from having financial difficulties after arriving at this University.
